1. Sealed tenders are invited for procurement of LED 40" from authorized dealers/agents/firms sales tax registered and national tax number holders as per specifications provided in the tender document.
2. **Forty-four LED 40"** will be provided as per specifications mentioned in the tender documents.
3. The LEDs will be supplied at the **National Management College, NM Wing, Opposite PC Hotel Lahore of a constituent Unit of NSPP, Lahore.**
4. The procurement shall be conducted in accordance with the PPRA rules as modified from time to time on single stage two envelopes procedure.
5. A single package containing separate technical proposals and financial proposals duly completed, each page signed stamped, and in complete conformity with tender document should be dropped in the tender Box placed at **Directing Staff (Admn.) NSPP Opposite PC Hotel Shakra-e-Quaid-e-Azam Lahore no later than 5<sup>th</sup> September 2017, 10:30 am. The Technical Proposals and tenders will be opened on the same day at 11:00 am in the Directing Staff (Admn.) office in the presence of bidders / their representatives who opt to be present.**
6. The LEDs will be inspected at respective station of delivery through an authorized surveyor; it can be rejected if not found according to the given specifications. The rejected items will be removed / replaced by the supplier at his own expense. The LEDs must be brand New and complete in all respects with original packing of manufacturer and strictly conforming to the given specifications. Delivery and warranty has to be provided onsite mentioned above.
7. The bidders must clearly mention the warranty and efficiency of the LED(s) with period for which free service of parts will be provided.
8. The bidders must provide certification regarding the LEDs being brand new and previously unused.
9. The firms must quote the rates of all the items as mentioned in the tender document.
10. Tender documents may be obtained from the office of Deputy Director (Admin), National Management College, Shakra-e-Quaid-e-Azam, Lahore during working hours. Photocopies will not be accepted.
11. The Tender document fee non-refundable will be charged @ Rs. 500/-.
12. Each page of the tender shall be signed and stamped. Bids which are incomplete, not sealed, not signed, unstamped, late or submitted by other than specified mode will not be considered.
13. Unit price must be quoted in Pak rupees including GST.
14. The bidder shall attach with the tender valid certificate of the principal of having been appointed as authorized dealer/firm/agent.
15. 2% of the bid amount shall be deposited along with the tender documents as earnest money in the form of CDR/demand draft/pay order of a scheduled bank of Pakistan in the name of Directing Staff (Admin), NSPP.
16. Income tax /sales tax registration certificate and other documents as mentioned in tender documents must accompany the bids. All taxes will be deducted as per Government rules.
17. NSPP reserves the right to reject all bids at any time prior to acceptance of bid.
