

This intensive program is aligned with the certification standards set by the Securities & Exchange Commission of Pakistan (SECP) and is designed to build capacity in governance, oversight, and compliance.

- Strengthen oversight through effective use of board committees (Nomination, Audit, HR).
- Ensure compliance with financial planning, corporate intent, and transparent reporting.
- Manage controls, audits, compliance, and director accountability.
- Integrate SECP and global best practices for effective leadership in public enterprises.
